
#### **Briefs**

Most notably, the progress made by the Kingdom for the second year in a row in the "Women, Business and the Law 2021" report issued by the World Bank, which aims to compare the level of gender discrimination in the field of economic development and entrepreneurship among (190) countries.

The newsletter included His Excellency Dr. Majid Al-Qasabi's statement during the first media meeting organized by the NCC, as His Excellency confirmed that the Kingdom is undergoing an unprecedented transformation and mobility in all aspects, indicating that the aim of enhancing competitiveness is not for further progress in international reports and indicators, but for the country and its citizens.

# The Council of Ministers Praised the Kingdom's Progress for the Second Year in a row in the Women, Business and the Law 2021 report

His Excellency, the Minister of Media, Dr. Majid Al-Qasabi, stated during the Saudi cabinet's weekly meeting, chaired by the Custodian of the Two Holy Mosques King Salman bin Abdulaziz, the Kingdom's progress for the second year in the Women, Business and the Law 2021 report recently published by the World Bank Group. The report ranked Saudi Arabia among the leading countries in the MENA region for the empowerment of women.

Dr. Al-Qasabi said that the initiatives implemented as part of the Kingdom's



Vision 2030 have helped to support the introduction of legislative reforms designed to enhance and expand women's role in the nation's economic development and make the Kingdom more competitive regionally and globally.

## Saudi Shura Council demands financial and human cadres' support for the National Competitiveness Center and the expansion of its international partnerships

The Shura Council held a session to discuss the National Competitiveness Center's (NCC) annual report for 2020 and requested to support the NCC's budget with the necessary financial allocations and human cadres to raise the operational efficiency and achieve its goals.

The Shura Council called on developing effective communication mechanisms and expanding international partnerships with organizations concerned with the investment environment reforms, thus contributing to competitiveness reports and building national competitiveness-related capacities.



The economic and energy committee of the Shura Council had begun to discuss the NCC's annual report at its meeting held in December 2020, chaired by Dr. Faisal Al-Fadhel. With Her Excellency's participation, the Assistant Minister

of Commerce, CEO of NCC, Dr. Eiman Al-Mutairi.

Al-Fadhel pointed out that the committee's discussion of NCC's report comes as an embodiment of the Shura Council's supervisory role, pointing out the NCC's important role in raising the competitiveness of government services and its advancement.

His Excellency the Minister of Commerce, Chairman of the Board of Directors of the National Competitiveness Center (NCC), Dr. Majid Al-Qasabi, stated that the Kingdom is making serious steps towards achieving its objectives in building a business environment that attracts local and foreign investment.

"The Kingdom is undergoing an unprecedented transformation and mobility in all aspects," Said Al-Qasabi during a media meeting at the NCC headquarters, indicating that promoting competitiveness is not for the world, nor for international reports but for our children.

During the meeting, the Assistant Minister of Commerce, CEO of the NCC, Dr. Eiman Al-Mutairi, said that the center is working in collaboration with more than 50 government entities and the private sector to improve the business environment in the Kingdom and raise its global competitiveness. Therefore, more than 770 reforms were launched and implemented to address the private sector's challenges, including reforms related to legislative and procedural aspects.

It is noteworthy that the NCC's media meeting aims to highlight the most prominent economic reforms to improve the business environment in the Kingdom.

#### Saudi Arabia Maintains its strong Reform Momentum in Women Legal Reforms

For two years in a row, Saudi Arabia has achieved notable progress in the "Women, Business and the Law (WBL) Report", a global measure of women legal reforms published by the World Bank Group.

On a scale of 1 to 100, the Kingdom scored 80 in WBL 2021, up from 70.6 in WBL 2020. Its performance is most remarkable in five indicators on which it scored at the top of the scale: mobility, workplace, pay, entrepreneurship, and pension. These scores put Saudi Arabia on a par with many advanced economies with long traditions of women legal reforms.



The Kingdom's strong performance comes as a result of a raft of reforms that it implemented last year to further expand women's participation in the economy. Saudi Arabia equalized women's access to all types of jobs in the labor market, lifted restrictions on their employment in sectors previously considered unsafe, and eliminated the ban on women's night work. Commenting on the results, His Excellency Dr. Majid Al-Qasabi, Minister of Commerce and Chairman of the Board of the National Competitiveness Center, indicated that the Kingdom's performance reflects the commitment of the Custodian of the Two Holy Mosques to enable Saudi women to fully participate in the social and economic development of their country. They also reflect the unwavering attention that HRH Crown Prince Mohammed Bin Salman has

dedicated to ensuring an effective wholeof-government approach to implementing women legal reforms.

Saudi Arabia's new reforms build on a succession of similar reforms that it has implemented since the launch of Vision 2030 in 2016, including lifting restrictions on women's mobility, equalizing access to public services, guaranteeing equal benefits in the labor market, and instituting protections against harassment in the workplace and in public spaces, among other reforms.

Women, Business and the Law report, a yearly publication of the World Bank Group, assesses and reports on women legal reforms in 190 countries around the globe, using an index with eight indicators: mobility, pay, parenthood, assets, workplace, marriage, entrepreneurship, and pension.

These results place the Kingdom of Saudi Arabia among advanced economies with a historical depth in implementing reforms in laws and regulations related to women.

#### Saudi Minister of Commerce Launches "Public Consultation Platform"



His Excellency Minister of Commerce, Chairman of the Board of the National Competitiveness Center, Dr. Majid bin Abdullah Al-Qasabi, launched the "Public Consultation Platform", which is a unified electronic platform aims to receive the views and feedback of the public and the government entities.

The goal of "Public Consultation Platform" is to enable the public and the government entities to express their views and feedback on law projects, regulations related to economic and development affairs before they are approved; and that is in implementation of the Council of Ministers Resolution No. (476) on March 10, 2020.

In this context, the National Competitiveness Center "TAYSEER" has developed the work and governance mechanism for the "Laws and Regulations Support Unit", as well as the "Public Consultation Platform". In addition to circulating that to government entities, organizing the publishing process, and collecting the public consultation feedback on any proposal related to the economic and development affairs for the law projects, regulations, and decisions of a regulatory nature or amending the applied ones. Moreover, a form was developed to evaluate and measure the regulatory impact, and some guidelines were prepared to enable representatives of government entities to use the platform efficiently.








## Dr. Eiman Al-Mutairi Participates in a Discussion Organized by the World Bank to Celebrate International Women's Day













To mark International Women's Day, Dr. Eiman Al-Mutairi, Assistant Minister of Commerce and CEO of the National Competitiveness Center (NCC), participated in a discussion organized virtually by the World Bank on Monday, March 8th, 2021. Al-Mutairi confirmed Saudi Arabia's progress in enhancing women's economic opportunities after the recent legislative reforms implemented.

Joining the World Bank Vice President for the Middle East and North Africa (MENA), Ferid Belhaj, and notable influencers and leaders in the MENA region, Al-Mutairi, highlighted the Kingdom's efforts in lifting the ladder for Saudi women. She also discussed the country's legislation's improvement, which boosted the

Kingdom's ranking in the Women, Business and the Law (WBL) report.

Al-Mutairi pointed out that Saudi Arabia's rank in the WBL report rocketed within one year, lifting the Kingdom from the lowest ranking in 2019 to the top in 2020 with 45 points increase.

"I think it was the biggest jump ever. We (Saudi Arabia) were the first in the Gulf region and the second in the Arab world. To us, that gave us a lot of pride. This complete change of laws and regulations happened in almost less than two months."

She also mentioned how the Kingdom had become a pioneer for the Islamic world in legislative reforms for women.

# Al-Qasabi: Lawyers are essential partners of the judicial system; they enhance the course of justice in commercial courts









His Excellency Minister of Commerce, Chairman of the Board of the National Competitiveness Center (NCC), Dr. Majid Al-Qasabi, held a virtual open meeting with a group of lawyers to review the most prominent reforms and achievements that serve investors in the Kingdom to start their commercial activity.

The meeting also highlighted the most significant reforms in the legal system, identified the most prominent challenges to study, and suggested appropriate solutions.

During the meeting, Al-Qasabi discussed how lawyers are essential partners of the judicial system in achieving justice and realizing rights and enhancing the course of justice in commercial courts, affirming that the Kingdom witnessed a remarkable renaissance in this field.

Al-Qasabi referred to the recent cabinet decision to correct the status of investors and said: "Behind every violation of the Commercial Concealment Law is a Saudi person,"

Therefore, the Ministry of Commerce will work

with the Saudi Bar Association to correct the parties' status.

Al-Qasabi emphasized the Ministry of Justice's efforts to achieve an unprecedented development to improve the commercial environment systems and facilitate lawyers' work.

The Deputy of the Minister for Laws and International Cooperation, Sheikh Abdullah Al-Sulaimi, confirmed that the ministry had made a quantum leap in the court systems. This leap helped strengthen the parties' role in organizing litigation procedures, activating alternative means, determining electronic litigation procedures, and enabling the public to access commercial case data. "The new litigation law established specific mechanisms to prove many issues," Al-Sulaimi said.

The Undersecretary of the Ministry of Commerce for Commercial and Investment Business, Abdulsalam Al-Mana, said: "The investor's journey to start a commercial activity has become easy and flexible."

The National Competitiveness Center (NCC) has played an active role in legislative and procedural reforms to improve the business environment during 2020 by working with all government entities and the private sector despite the challenges that the world has faced due to the

NCC played its prominent role in enhancing the Kingdom's competitiveness and harmonizing government entities' strategies around a unified vision by developing the legislative and procedural environment to make the Kingdom among the world's top ten competitiveness countries in 2030.

NCC launched the Public Consultation Platform "Istitlaa" to achieve its strategic objectives. The platform aims to enable the general public and government entities to provide their views and observations on draft laws and regulations related to economic and development affairs before they are approved. That is in implementation of the Council of Ministers Resolution No. (476) on March 10, 2020.

NCC develops the work and governance mechanism for the "Laws and Regulations Support Unit" by preparing survey forms and collocate notes on laws and regulations related to economic and development affairs in the Kingdom, by preparing the poll models to evaluate their

impacts and circulating them to government entities. In addition to some guidelines prepared to enable representatives of government entities to use the platform with high efficiency.

Several law projects and regulations were proposed through the Public Consultation Platform, most notably the draft Labor Law amendment project and the draft laws for the anti-concealment law prepared by the Ministry of Commerce. The draft anti-concealment law aims to support small and medium businesses and protect the investor and consumer from the harmful practices resulting from the phenomenon of concealment and curbing the sources of concealment and the supply chains associated with it. In addition to the draft criteria for licensing real estate consultancy and analysis of real estate markets, the draft calculation rules of Zakat of the taxpavers estimated for the second issue. the draft guideline for the requirements for approval of advertising medical devices and products, the draft amendment to the executive regulations of the commercial names law, the draft of the Agricultural Development Fund law, the draft amendment of the corporate governance regulation, and other projects in addition to the regulatory guides such as the guide for

Swak, and the guide to Child-Resistant and Sen-

ior-Friendly Packages.
