This newsletter also includes the major economic projects that His Royal Highness the Crown Prince recently launched, and at the forefront of which is the Saudi Green Initiative. As well as establishing OXAGON industrial city at NEOM and launching strategic offices to develop Al Baha, Al Jouf, and Jazan regions to establish then future development authorities. In addition to the establishment of Prince Mohammed bin Salman Non-Profit City, which is the first nonprofit city in the world, and approving the master plan for the "Downtown Jeddah" project.

This newsletter also covers the internal and external activities of the NCC, such as the Acting Governor of Riyadh receiving the Minister of Commerce, COB of the NCC, and the Ministry's officials. In addition to the regular meetings with the American Chamber of Commerce, receiving ambassadors and business delegations visiting the NCC, and the workshops and seminars aimed at monitoring and analyzing the obstacles facing the business environment and proposing solutions to enhance the Kingdom's competitive environment.

NCC, in Cooperation with UNCITRAL, Organizes a Webinar on "Digital Economy Law"





NCC Organizes a Workshop to Enhance the Economies of Dates

Prominent Themes:

- Saudi Arabia aims to reach 2.5 billion riyals of exports in 2025
- Current procedures that hinder investors and entrepreneurs in the dates production sector and related supply chains

- Ease of procedures for obtaining international practices certificates for Organic Farming and Sound Fgriculture
- Challenges facing investors at the level of laws and regulations

During the meeting, which was held on December 8, 2021, Dr. Al-Mutairi stressed the importance of strengthening economic ties between Saudi Arabia






