
The newsletter covered His Royal Highness Prince Mohammed bin Salman bin Abdelaziz, Crown Prince, Prime Minister, and Chairman of the Royal Commission for Riyadh City participation in the Kingdom's Official Reception for delegates of 179 member countries of the Bureau International des Expositions, which was held in Paris by the Royal Commission for Riyadh City to support Riyadh's bid to host the World Expo in 2030.

The newsletter included coverage of the Kingdom's advancement by 7 ranks compared to last year in the World Competitiveness Yearbook 2023, published by the World Competitiveness Center of International Institute for Management Development (IMD), ranked 17th globally out of 64 countries that are the most competitive in the world, surpassing countries with advanced economies.

It also highlighted the visit of a high-ranking Saudi delegation to London, with the goal of enhancing intra-trade in products and services and raising the level of economic partnership between the two friendly countries, as well as reviewing a number of projects to boost the Kingdom's competitiveness in various sectors.

Further, the newsletter reviewed the most notable studies and research published by international organizations in the second quarter of 2023, as well as the NCC's local and global activities, including holding the "UK-Saudi Business, Trade and Partnership Forum" in London, in collaboration with the Saudi British Joint Business Council and the Federation of Saudi Chambers, as well as the NCC's efforts to support the legislative environment through seminars, workshops, and meetings that discussed the Kingdom's promising opportunities, as well as the exchange of experiences and best practices in related fields with a number of foreign delegations.

This comes as the Riyadh candidacy file is receiving unconditional support from the Kingdom's leadership, along with joint efforts from all government agencies, as well as the contribution of Saudi society.

### IMD: Saudi Arabia Ranks 17th Globally in World Competitiveness Yearbook 2023

Saudi Arabia ranked 17th globally out of 64 countries that are the most competitive in the world, to become one of the top 20 countries for the first time in the World Competitiveness Yearbook 2023, published by the World Competitiveness Center of International Institute for Management Development (IMD). This report is one of the major competitiveness reports that the National Competitiveness Center monitors and analyzes in collaboration with the relevant government entities.

The Kingdom advanced (7) ranks in the World Competitiveness Yearbook 2023, owing to strong economic and financial performance in 2022 as well as improved

business legislation, ranking the Kingdom as the 3rd most competitive economy among its G20 peers, ahead of countries of advanced economies such as Republic of Korea, Germany, France, Japan, Italy, India, United

Continuous Progress Toward Global Competitiveness

Kingdom, China, Mexico, Brazil, and Turkey. the Kingdom's Reacting to positive performance, the Minister of Commerce. Chairman of the Board of Directors of the National Competitiveness Center (NCC), Dr. Majid Al-Kassabi, confirmed that the Kingdom's positive results in the World Competitiveness Yearbook 2023, as well as other prestigious international reports, are a reflection of the economic transformation process implemented by the Kingdom's government in accordance with HRH Crown Prince's directives.

The Kingdom made progress in three out of four main Competitiveness Factors assessed by the report: from 31st to 6th position

in economic performance; from 19th to 11th in government efficiency; from 16th to 13th in business efficiency; while maintaining its previous infrastructure ranking (34th).

The delegation that visited London included H.E. Dr. Eiman Al-Mutairi, Vice Minister of Commerce and CEO of the NCC, and 45 officials from 22 government, private, and non-profit entities.

The forum's activities were attended by His Royal Highness Prince Khalid Bin Bandar Bin Sultan Bin Abdelaziz, Ambassador of the Custodian of the Two Holy Mosques to the UK, Mr. Neil Crompton, British Ambassador to Saudi Arabia, and Sir William Russell, Lord Mayor of the City of London.

His Excellency the Minister of Commerce and Chairman of the Board of Directors of the National Competitiveness Center (NCC) confirmed that the Cabinet's approval of the Kingdom to join the UN Convention on the international sale of Goods (CISG) reflects the Saudi government's efforts to boost the growth of the business sector and keep pace with Legislative reforms and new regulatory frameworks that enable the integration of the Saudi economy with regional and global economies.

Further, Al-Kassabi added that the Convention, to which the National Competitiveness Center submitted a proposal for the Kingdom to join, will allow for the adoption of regulatory and legislative frameworks for cross-border trade, which helps in the adoption of a unified

ecosystem governing the conclusion of these contracts and boosts the growth of the Saudi economy in light of the Convention's accession by 95 countries, which account for roughly two-thirds of the global economy.

The Convention aims to provide a unified and flexible legal framework for cross-border contracts for the international sale of goods, as well as a neutral and independent international regulatory framework for handling disputes for the international sale of goods, as well as the inclusion of a modern set of legal rules that take into account various economic and social aspects and contribute to the removal of obstacles in international commerce and development, as well as efforts to diversify the economy and improve cross-border business transactions of small and medium enterprises (SMEs).

In order to achieve the objectives of Saudi Vision 2030 related to raising the Kingdom's competitiveness regionally and globally, the National Competitiveness Center (NCC) studies, analyzes, and follows up on about 27 significant international reports to monitor the Kingdom's performance in the indicators of those reports through monitoring and analyzing global indicators and reports related to competitiveness and comparing the Kingdom's performance with other leading countries, as well as listing the most important indicators and

specialized reports in various fields, referring them to the concerned government entities, and proposing appropriate recommendations for their implementation. The significance of these global reports stems from monitoring and analyzing the country's competitive performance within the context of its strategy in a way that reflects the development and improvement efforts made to improve the country's indicators and contributes to raising competitiveness and strengthening its global position.

# NCC Organizes a Workshop on "Intellectual Property Law"



The National Competitiveness Center, in cooperation with the Saudi Authority for Intellectual Property, organized two workshops on the "Intellectual Property Law" and "Development of Patents, Layout Designs of Integrated Circuits, Plant Varieties and Industrial Models Law", to highlight the most prominent provisions of both projects, in the presence of Her Excellency the Vice Minister of Commerce and CEO of NCC, Dr. Eiman Al-Mutairi and H.E. the CEO of the Saudi Authority for Intellectual Property, Dr. Abdelaziz bin Mohammed Al-Swailem The first workshop which was attended by more

than 200 participants from relevant government

entities and the private sector aimed at achieving the project's goals, which included improving the intellectual property legislative environment.

While the second workshop titled "Development of Patents, Layout Designs of Integrated Circuits, Plant Varieties and Industrial Models Law", emphasized a series of main topics, most notably splitting the protection issues described in the project system into four autonomous systems and presenting utility models in the Kingdom as one of the intellectual property areas.

# NCC Holds Training Workshop on "Enhancing Productivity" in Collaboration with the World Bank



The National Competitiveness Center, in collaboration with the World Bank held a workshop on "Enhancing Productivity- Measurement Procedures, Drivers, and Policies" two workshops on the "Intellectual Property Law", aimed at developing the competencies of Center personnel and workers from various government entities.

The two-day workshop focused on defining productivity theory, discussing basic concepts in productivity analysis, differentiating between total worker productivity and labor productivity, and the differences in productivity analysis between manufacturing and service fields.

## **Stagflation**Arab Monetary Fund





The Arab Monetary Fund published a report on "stagflation" in order to define the term, which combines two types of difficulties confronting the world's economies: "inflation and stagnation".

The report reviews general frameworks, policies, and recommendations to combat stagflation, which must be implemented in parallel with several considerations, such as taking into account the environment in which these policies will be implemented, targeting the most harmful groups and sectors, balancing short and long-term considerations, and achieving a balance between dealing with inflation and dealing with stagnation.

# How Space Applications Can Benefit Agriculture World Economic Forum



The World Economic Forum published a study titled "Studying Space Technology Applications in the Agricultural Sector and Their Importance," which aimed to review the applications of satellite data and remote sensing to improve agricultural information and insights, as well as their role in providing solutions to food insecurity, climate action, and water availability.

This study compares satellites as a source of agricultural imaging with other sources in terms of cost criteria, flexibility, degree of complexity, and risks, as well as shedding light on the World Economic Forum's most prominent proposals to improve satellite use and address any obstacles and challenges.





The National Center for Competitiveness' public consultation platform allowed the public, as well as the private sector and government entities, to express their opinions and provide feedback on law and regulation projects related to economic and development affairs before they were approved, thereby contributing to the improvement of the business environment and the Kingdom's competitiveness.
