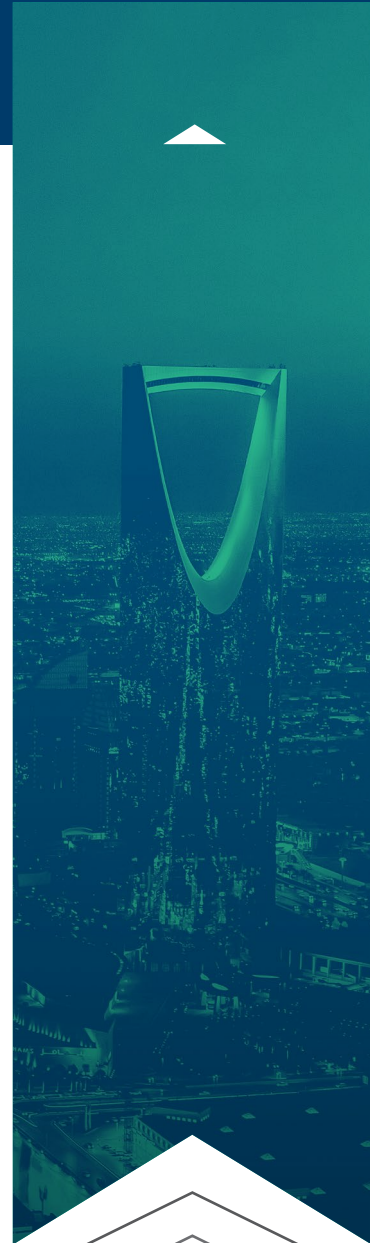
## Briefs

The National Competitiveness Center's (NCC) second quarter newsletter 2021 coincides with the Saudi Vision 2030's fifth anniversary, highlighting the progress and achievements witnessed at a local, regional, and international level.

The newsletter includes the most prominent activities and visits, including the reception of the ambassadors of Belgium and Mexico to the Kingdom, at NCC's headquarters to discuss aspects of strengthening and developing bilateral cooperation and coordination and discussing several issues of common interest.

## Five Years Since the Launch of the Saudi Vision 2030



▶ HRH Crown Prince Muhammad Bin Salman discussed the most prominent achievements of the Kingdom's Vision 2030 programs and projects over the past five years in an interview broadcast by the state's television and the most important Arab television channels.

He explained that the volume of income and growth achieved by oil is much greater than our needs at that time, specifically in the last thirties and forties, adding that the volume of the surplus of income and economic growth was hundreds of times more than we aspire to.

He stressed the Kingdom's desire to maintain the level of quality of life and its continued growth. In addition to the risk that the Kingdom's economy depends mainly on oil and what confronts oil in the next forty or fifty years of challenges and lack of use, and oil price decrease in the long term.

On a question about what comes after the Kingdom's Vision 2030? the Crown Prince replied that planning is ongoing and that the vision places us in a very advanced position in the world, but 2040 will be the stage of global competition.

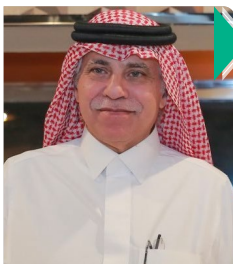

The Vice Minister of Commerce, CEO of the National Competitiveness Center (NCC), Dr. Eiman Al-Mutairi, participated in the panel discussion “Building the Future of Saudi Arabia”. The panel discussion was organized by “WIL Digital Talks” in cooperation with (IE) University in Spain, with many experts, academics, and specialists attending worldwide.

During the virtual event conducted by the President of IE University, Prof. Santiago Iñiguez, Al- Mutairi said that the “Saudi Vision 2030” is a project for construction, development, and transformation from the dependence of oil and gas resources to a diversified economy that depends on the capabilities and energies of the Saudi citizen.

She added that the Kingdom represents a great investment powerhouse, describing it as the heart of the Arab and Islamic world, which has enormous opportunities available to local and

foreign investors in various sectors.

Al-Mutairi pointed out that the Kingdom has a prominent strategic location. It is the crossroads between Asia, Europe, and Africa and seeks to become an advanced global logistics center.

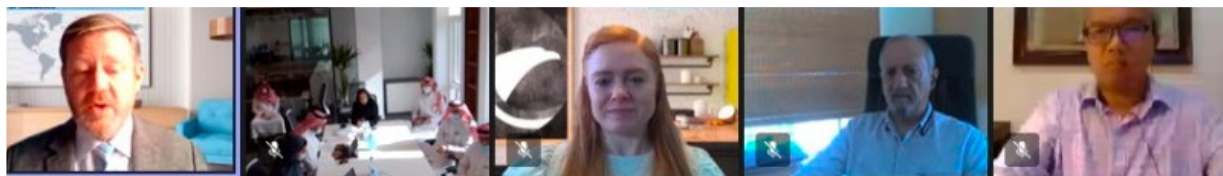
Belgium to Saudi Arabia, Dominique Mineur.

to Saudi Arabia, Anibal Toledo.

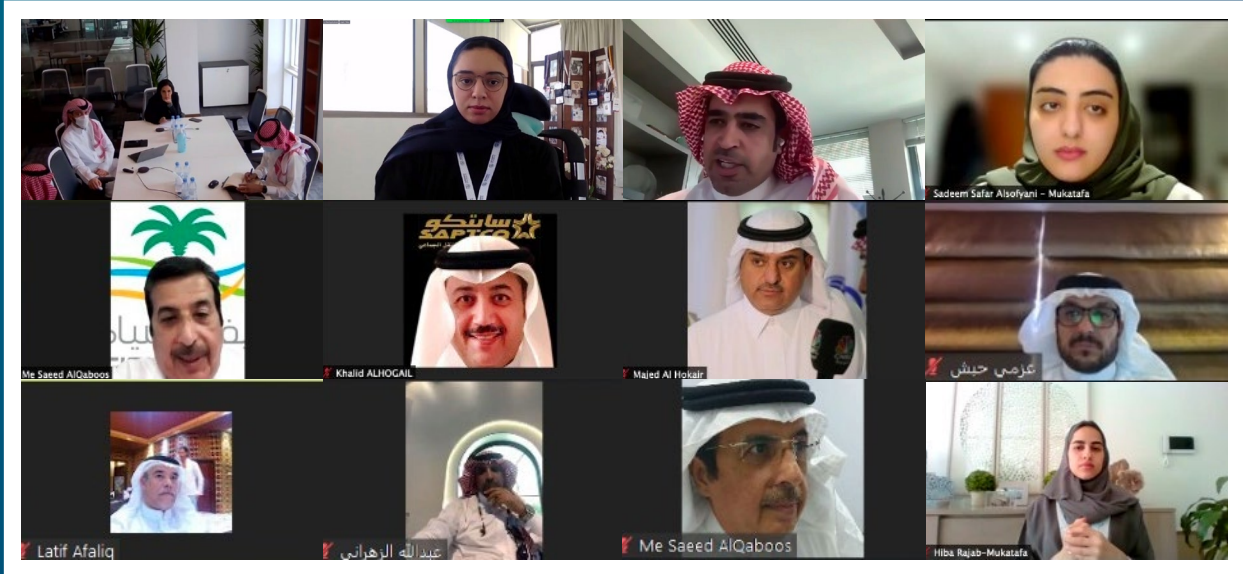
During the meeting, they reviewed relations between the two friendly countries, ways of enhancing bilateral cooperation and coordination, and several topics of common interest.

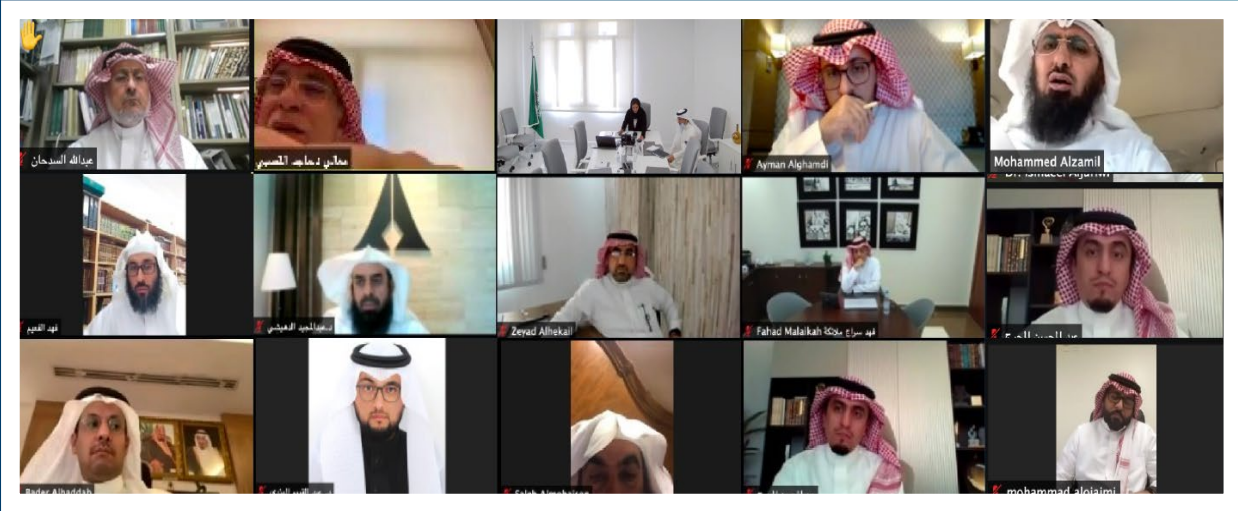
## NCC Organizes a Workshop on The Competitiveness of the Tourism Sector

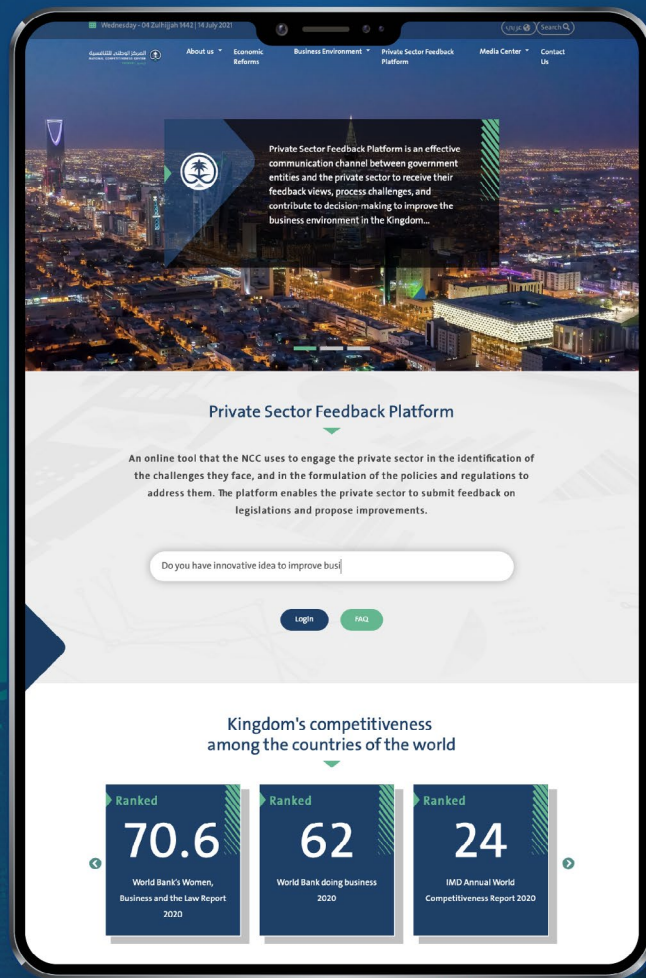
